

**2024 Keystone Make Your Way Out Giveaway  
Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.**

1. **Eligibility:** The 2024 Keystone Make Your Way Out Giveaway (the "Promotion") is open only to legal residents of the 50 United States (excluding Hawaii, Puerto Rico, and other US territories & possessions), the District of Columbia, and Canada (excluding Quebec) (the "Territory") who are 18 years of age or older and are located in the Territory at the time of entry. Kampgrounds of America, Inc. ("Sponsor"), Sponsor franchisees, Keystone RV Company, SweepstakesPros ("Promotion Administrator") and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate. The Promotion is subject to all applicable federal, state/provincial/territorial, municipal and local laws and is void outside the Territory and where prohibited by law.   - a. **Online Entry:** During the Promotion Period, go to [www.makeyourwayout.com](http://www.makeyourwayout.com) (the "Website") to locate the official entry form. Follow the on-screen directions, complete all required registration fields and submit to enter ("Online Entry"). You will receive one (1) entry in the Promotion for each Online Entry received. Entrants must complete all required information. LIMIT ONE (1) ONLINE ENTRY PER PERSON/EMAIL ADDRESS PER DAY.
  - b. **Share Entry.** After you have entered the Promotion, you may earn additional entries by sharing the Promotion on Facebook or X (formally Twitter) (each a "Share"). Click on the Facebook and/or X (or Twitter) share link on the Website and share the post from your X account or share on your Facebook timeline (each a "Share Entry"). Each Facebook or X post must contain the hashtag #KOASweepstakes. You will receive one (1) entry in the Promotion for each person that enters the Promotion via Online Entry after clicking on the link in your Share. You will receive a Share Entry: a) only once per referred friend; b) only the first time your friend successfully enters the Promotion; c) only if your friend has not previously entered the Promotion; and d) only if your friend enters the Promotion via Online Entry immediately after clicking on the link contained in your Share. You may only refer persons with whom you have an existing personal relationship and with whom a message from you would not be considered spam. THERE IS NO LIMIT TO THE NUMBER OF SHARE ENTRIES PER PERSON/EMAIL ADDRESS.

All entries become the exclusive property of the Sponsor and will not be acknowledged or returned except as provided herein. Entries which are incomplete, incorrect, incomprehensible, not received, or do not otherwise comply with these Official Rules will be void and will not be entered into the Promotion's prize drawing. Entries made by any other manner not specifically allowed under these Official Rules will not be entered into the Promotion and may result in disqualification of the responsible entrant. You are not a winner until your prize claim is validated and you receive official

written notification from the Sponsor or the Promotion Administrator. In the event of a dispute regarding the identity of the person submitting an entry, the entry will be declared made by the person in whose name entry was made.

5. **Prizes, Approximate Retail Value ("ARV") & Odds of Winning:** One (1) Grand Prize which includes:

    - i. Springdale Classic Mini1800BH (ARV \$17,025) or
    - ii. Hideout Sport 178RB (ARV \$17,025)
  - b. One (1) \$500 USD KOA Gift Card.
  - c. \$1,000 USD awarded in the form of a check.

Total ARV of all prizes is up to \$18,525 USD. If winner is more than 100 miles from the dealership where he/she will pick up the RV prize, Sponsor will reimburse winner for gas up to a maximum of \$500.
